

Start Claim - The Treaty is the joining of two sovereign nations formal agreement between two independent nations, establishing mutual recognition, cooperation, or shared governance. It entails each nation's independent authority, with agreements ensuring collaboration while maintaining each nation's rights. The "Now-Time-Command-Claim" refers to a claim asserting authority or action in the present moment, legal, political, and sovereign.

These sovereignty claims are to assert autonomy.

Clause 1 - A Mutual Treaty of Volition and Acceptance: Each nation accepts the treaty and the title-deed. The Authentic Values of both nations acknowledge the authenticity of their mutual values. The agreement is dated September 28, 2024. The Trust and Command is these nations agree to a joint trust motion, asserting ownership, duty, and command over the terms of the treaty and the documentation.

This treaty emphasizes sovereignty and cooperative governance.

Clause 2 - The clause is referencing a series of our historical treaties, declarations, and legal claims involving the sovereignty of indigenous nations, particularly in Aotearoha(Aotearoa)[New Zealand] and Gondwana[Australia]. The mention of documents such as He Whakaputanga o te Rangatiratanga o Nu Tireni, 1835 (Declaration of Independence) &: Te Tiriti o Waitangi 1840(Treaty Of The Waitangi) &: Letter from Queen Victoria 1858 addressing Rangatira, Kings, Queens, Law-Makers &: Memorial of Rights 1975 &: Rangihou Sovereign Nation Treaty Gondwana[Australia] 2014 &: Royal Decree Command Judgement 2020 &: Crown Royal Charter 2021 &: Letters Patent Aotearoha(Aotearoa)[New Zealand] Whenua 2021 &: Te Ture Whenua Maori Maori Land Act 1993 which highlights significant milestones in the Mauri Nations legal and colonial history. These are foundational to the recognition of Mauri rights and sovereignty.

Clause 3 - This clause is referencing various legal and historical documents related to the sovereignty and land rights of the Mauri(Maori) people in Aotearoha(Aotearoa)[New Zealand]. It highlights the relationships of He Whakaputanga o te Rangatiratanga o Nu Tireni, 1835 (Declaration of Independence) &: Te Tiriti o Waitangi, and the concepts of sovereignty, land titles, and governance. It emphasizes the Sovereignty Claims of the Crown of the Mauri Nation and their rights over land and governance. It mentions significant historical treaties, declarations and agreements that establish and reaffirm these rights. It discusses the legal foundations for the Mauri(Maori) governance structure and the relationship with the Settlers Parliament.

Clause 4 - This clause describes the appointment of Lady-Crown-Tuikatuku-111 and John: Flanagan as Post-Masters over the lodial land title locations of Aotearoha(Aotearoa)[New Zealand] and Éire. This appointment is recognized under a formal Global Postal Treaty Document Command Claim, with a specific date of September 28, 2024. These sovereign individuals, live life claimants are granted authority through this global postal treaty, and the claim includes acknowledgment of the sovereignty and duties tied to these lodial land title locations.

Clause 5 - Is a formal declaration regarding the Aotearoha(Aotearoa)[New Zealand] United Tribes Flag 1834/1835 Nation Command Claim. It references the Lodial Land Command Claim of Aotearoha(Aotearoa)[New Zealand] and asserts sovereignty, Voiding/Negating any claims associated with the HER MAJESTY QUEEN IN RIGHT OF NEW ZEALAND SEC CIK 0000216105 Corp-oration/Dead Entity, Births Deaths and Marriages Act 1995, the Constitution Act 1986, the Local Government Act 2002, and the Resource Management Act (1991), under the authority of Lady-Crown-Tuikatuku-111's volition-command claim.

Clause 6 - Asserts the sovereign command claim of the Maui Nation over the lodial land location of Aotearoha(Aotearoa)[New Zealand]. The reference date is October 28, 1835, which relates to the He Whakaputanga o te Rangatiratanga o Nu Tireni, 1835 (Declaration of Independence), marking an important historical sovereignty claim by the indigenous Māori people. This clause, asserted by Lady-Crown-Tuikatuku-111, emphasizes a continued and unbroken claim to sovereignty and authority over the land in present time through the concept of "Now-Time-Continuation."

Clause 7 - Outlines the Mauri Crown and the Crown of the Mauri Nation's oath regarding the lodial lands of the Sovereign Nation State of Éire and Aotearoha(Aotearoa)[New Zealand]. It highlights a joining and advancement between the two sovereign nations, emphasizing a shared equal volition, fostering cooperation, and building a strong relationship between both sovereign nations. The clause promotes mutual respect and coordination, referring to the cordial position of both nations as they uphold their respective claims to sovereignty and land.

Clause 8 - Asserts the deed claim of the treaty, emphasizing the acceptance and bond between the two sovereign nations through their members' autographs, thumbprints and seals, dated September 28, 2024. It details certification under the Global Postal Treaty and outlines compliance with specific syntax rules related to legal and grammatical structures. The clause also mentions the Global Gold Laws and is finalized by the Chief Post Master General, Jason-Paul Greaves, indicating an official endorsement of the treaty's terms and conditions in "Now-Time-Continuation."

Clause 9 - Asserts a command claim dated April 24, 1916, relating to the Hibernia Flag State and the formation of lodial land in Éire. It references the I.R.B. Sovereign Command, including various charters and seals, while also safeguarding against void claims from historical acts such as Schedule-1 & 2 & Irish Presidential Charter Command Claim With The Void-Claims Of The Government Of Ireland Act 1920 &: Anglo Irish Treaty 1921 &: Crown Of Ireland Act 1542 &: Act Of Union 1801 &: Ministers & Secretaries Act 1924 &: 1916 Proclamation. This clause emphasizes the authority and governance structure as recognized by the Global Chief Post Master General, Jason-Paul Greaves, under the concept of "Now-Time Volition."

Clause 1.1 - Asserts the command claim of a sovereign nation regarding the lodial land location in Éire, specifically referencing the I.R.B. lodial grant from January 21, 1919. It notes a continuation of this claim and includes an executive command position grant, identified with specific numerical references. This clause emphasizes the ongoing legitimacy of the claim within a historical context, reinforcing the authority of the sovereign nation over the specified lands.

Clause 1.2 - Asserts the compliance command claim of the sovereign nations concerning the IRB location in Éire Territory and location of the Crown of the Mauri Nation. It emphasizes the current authority of each nation and their alignment with the Global Postal Treaty and Global Gold Laws within the context of commerce and lodial land contracts. This clause highlights the ongoing authorization and governance by the sovereign postal nations and their membership in global agreements, finalized by Global Chief Post Master General, Jason-Paul Greaves.

Clause 1.3 - Asserts the duty claim over the lodial land of the Mauri Sovereign Nation and the Sovereign Nation State of Éire. It emphasizes a mutual bond and collaboration between the two nations, highlighting their equal volition and shared responsibility.

The clause underscores a positive relationship, affirmed by the autographs, thumbprints and seals of each claimant, establishing a framework of cooperation and sovereignty that aligns with their current authority and obligations.

The term "Witness-Auto-Graph-Claims" is where the autographs and thumbprints of witnesses are documented to validate the claims made in the preceding clauses. Their mark serves as formal acknowledgment of the agreement and commitment outlined in the treaty document. The presence of these witnesses strengthens the legitimacy of the treaty claims being made.

The term "Mauri-Crown-Auto-Graph & Seal" is where the autograph, thumbprint and official Great Seal of the Crown of the Mauri Crown is represented, which serves as an authenticating mark for the legal and ceremonial signing. This signifies the authority and legitimacy of the claims made under the Mauri Crown, potentially linked to the sovereignty of the Mauri Nation and their agreements. The inclusion of a seal indicates a formal endorsement of the content and intentions of the treaty document.

The term "Éire-Auto-Graph & Seal" is where the autograph, thumbprint and official Great Seal of the Sovereign Nation State of Éire is represented, which serves as an authenticating mark for the legal and ceremonial signing. This signifies the authority and legitimacy of the claims made under the Éire Sovereigns, potentially linked to the sovereignty of the Sovereign Nation State of Éire and their agreements. The inclusion of a seal indicates a formal endorsement of the content and intentions of the treaty document.
